4.1 Description of first aid measures

5.3 Advice for firefighters

- Special protective actions for fire-fighters** : Promptly isolate the scene by removing all persons from the vicinity of the incident if there is a fire. First move people out of line-of-sight of the scene and away from windows. No action shall be taken involving any personal risk or without suitable training. 7.1 Precautions for safe handling

8.2 Exposure controls
